

# Summer Camp 2024

## Terms and Conditions

### Dates

Session 1: June 30 - July 13, 2024

Session 2: July 14 - July 27, 2024

Session 3: July 14 - August 4, 2024

Session 0 (Odyssey): July 28 - August 4, 2024

Stays of 4 or 5 weeks can be arranged on request

### Fee Structure

#### Fees include

- Transport for campers to and from Geneva airport (during the official arrival and departure dates)
- Language lessons in the chosen language (English, French, or Spanish) - 15 hours / week from June 30 - July 27
- Accommodation (not for day camp)
- Full board
- Afternoon activities
- Evening entertainment
- Laundry
- Health & Accident Insurance covering medical costs

#### Fees do not include (non-exhaustive)

- Personal expenses
- Pocket money (CHF 150 / week)
- Transfers outside of the official arrival and departure dates
- Transfers to other airports or train stations
- Transfers for medical appointments
- Supplement for campers arriving / departing with UM service: 150 CHF / way

### Cost

For 2 weeks: CHF 7130 (including CHF 1000 registration fee)

For 3 weeks (Session 2 plus Odyssey): CHF 10330 (including CHF 1000 registration fee)

For Odyssey (1 week): CHF 3700 (including CHF 500 registration fee)

Day camp for 2 weeks: CHF 5400 (including CHF 1000 registration fee)

### Payment Deadlines

The registration fee is due at the moment of sign-up.

The remaining camp fees are due by 1st March 2024.

Registrations passed this date will require immediate payment of the full amount.

We reserve the right to cancel the registration if no payment is received.

### Cancellation Policy

The registration fee of CHF 1000 is non-refundable.

Cancellation 60 days or more before the camp:  
50% cancellation fee.

Cancellation 59 days or less before the camp:  
100% cancellation fee.

The cancellation fee applies in all cases, including illness.

Parents may wish to take out separate cancellation insurance to cover such events. In case of an early departure from the camp, no refund will be made. This includes health related early departures from the camp.

The parents are responsible for the arrival and entry into Switzerland of campers. Securing a visa to allow entry to Switzerland, where necessary, is the responsibility of parents. Beau Soleil Summer Camp declines any responsibility in case of late arrival due to a visa problem or any other necessary documents for entry into Switzerland.



## Hazardous activities

While the camp takes all reasonable steps to keep campers safe, parents accept that there is some level of inherent risk in the range of activities provided by Beau Soleil. ## Responsibility for injury, damage, or loss

Beau Soleil Summer camp is not liable for accidents, injuries or damage to property suffered by campers, however so caused. Likewise, the camp cannot accept responsibility for accidents, injuries or damage to property caused by a student to a third party. Campers are responsible for their own belongings while at summer camp. If lost items are found around school, the camp will make reasonable attempts to return them to their owner.

The school cannot accept any responsibility in the case of the loss or theft of money, jewellery, items of clothing and / or other valuable objects which have not been explicitly entrusted to the safe keeping of the school. Parents are jointly and severally liable for any damage caused by campers during the camp.

## Behaviour and Conduct

Campers are expected to act responsibly and to follow the Summer Camp rules. Ongoing issues of behaviour will be reviewed by the Head of Summer Camp and may be referred to the Principal. Beau Soleil reserves right to search a camper's room or breathalyse a camper for alcohol if deemed necessary by the Head of Summer Camp for disciplinary reasons. Beau Soleil reserves rights to test a camper for drugs if deemed necessary by the Principal, who will make reasonable efforts to contact parents in advance.

Severe or repeated breaches of camp rules, including but not limited to use of alcohol or drugs, may result in immediate expulsion from the camp, at the sole discretion of the Principal. In such a case no reimbursement will be made, and all fees are due to the school; parents will be required to arrange immediate supervision and collection of the camper.

## Medical

Parents are required to complete the health form, which forms part of the terms and conditions for the Beau Soleil summer camp.

## Alterations to Programme

Beau Soleil Summer Camp offers a wide range of activities for the campers. The published programme is for guidance and changes might occur for logistic or meteorological reasons.

## Force Majeure

Beau Soleil Summer Camp can suspend or even stop, the courses and all other services, in particular the Camp, for reasons of force majeure, natural disasters (e.g. fire, floods, earthquakes, storms), explosions, epidemics, quarantines, sabotage, riots, civil unrest, strikes, war or any other similar circumstances affecting the sustainable operation of the holding of Beau Soleil Summer camp. In case of force majeure, the Parents acknowledge that the inability to provide the services is not attributable to Beau Soleil so that Beau Soleil is not due to provide any reimbursement, even partial. However, Beau Soleil is offering the option to defer to 2025 without penalty.

## Applicable law and jurisdiction

Swiss legislation alone is competent to arbitrate any litigation arising from the present contract, regardless of the parents' place of residence or that of a titular bearer of parental authority. Any difficulty arising from the present contract will be settled by the legislation of Canton de Vaud within the Aigle judicial district. The school reserves the right to make changes to the programme, the pricing, and the terms & conditions.
